Addressing the fall of the North Korean regime and post-collapse peacekeeping

Sponsors: China, Japan, Republic of Korea

Addressing the fall of the North Korean regime and post-collapse peacekeeping

The First Committee,

Affirming the role of the Committee on this issue,

Determined that the process of unification must be peaceful and cooperative,

Acknowledging the territory of unified Republic of Korea is a combination of the previous territory of Democratic People's Republic of Korea and the Republic of Korea,

- 1. *Requests* active cooperation which supports the unified Republic of Korea as a neutral, stable, peaceful, and sovereign state;
- 2. *Urges* establishment of an international denuclearization commission, which consists of nuclear experts from all member states and the International Atomic Energy Agency (IAEA) for the purpose of such as but not limited to:
 - a. utilizing the method of 'down-blending' to convert nuclear weapons facilities to nuclear power plants;
 - b. converting weaponized plutonium to nuclear fuel in order to utilize them as a power reactor for nuclear power plants;
 - c. providing technical consultations on the overall process of denuclearization;
- 3. *Further urges* member states to make appropriate efforts to accomplish complete denuclearization for peacekeeping processes, and exercise actions such as but not limited to:
 - a. Inviting People's Republic of China as a facilitator in the negotiations between the former North Korean military officials and the unified Republic of Korea;



- Inviting unified Republic of Korea to provide financial assistance to former North Korean officials in exchange for their information regarding the location of Weapons of Mass Destruction;
- 4. *Suggests* building economic stability within the unified Republic of Korea in ways such as but not limited to:
 - a. asking the unified Republic of Korea to offer special reductions in corporate tax in the North Korean regions regarding investments in infrastructure in order to facilitate the rapid provision of essential infrastructure in the North Korean region;

i.specific infrastructures that will be subject to special reductions of corporate tax will be determined in future committee meetings ii. additional discussion must be held in the recent future without delay

- b. conducting multilateral business cooperation to expand the Eurasian railway system to connect with the pre-existing railway system in the People's Republic of China and the unified Republic of Korea.
- Requesting the cooperative investments among the Asian Development Bank(ADB) and the Asia Infrastructure Investment Bank(AIIB) to provide crucial economic aid;
- d. Restarting Kaesong Industrial Complex to be expanded into the multilateral business starting with Japan and the People's Republic of China in request of possible priorities in the process of operating the industrial complex for the purpose of providing more regional job opportunities in the former North Korean region and attracting further foreign investments,
- e. Encourages the construction of a national park within the DMZ region for research purposes and tourism
 - i. the demining processes must be preceded before the construction process
 - ii. the demining processes should be eco friendly and of no harm to the ecosystem
- 5. Strongly recommends the unified Republic of Korea to endorse resource diplomacy with the People's Republic of China and Japan in ways such as but not limited to:inviting the unified Republic of Korea providing resources atat a lower price in exchange for the provision of certain technological aid from Japan and the People's Republic of China that would be further discussed through future commissions;
- 6. Reaffirms that the social integration process of the unified Republic of Korea shall embrace the cultures of both the Northern and Southern regions of the Korean Peninsula in order to ensure social stability among North and South Korean workers in ways such as but not limited to:
 - a. Understanding that it is necessary to provide jobs to North Korean soldiers in the aftermath of reunification such as but not limited to:
 - i. construction work that requires a large number of workers,
 - ii. simple labour suitable for illiterate soldiers,
 - Providing aids to the unified Korean government to build educational facilities to integrate North and South Korean knowledge such as but not limited to history values and language and support cultural exchange,
 - i. utilizing the North korean defectors existing in places such as but not limited to the united ROK and Japan

- ii. the North korean defectors will assist educational professionals to establish an integrated educational program for the youth in both regions of the Korean peninsula
- iii. the North Korean defectors will also train cultural educators who will educate the general public for the purpose of narrowing the cultural gap between the two regions regarding history, language and values
- iv. such educators will help make educational videos and content that the general public can easily access
- 7. Further requests humanitarian aid to be distributed in the former North Korean region in ways such as providing medical aid, shelter and food in cooperation with NGOs such as but not limited to:
 - the World Food Programme(WFP), the International Federation of Red Cross(IFRC), UNICEF, UNHCR, MSF, WHO and the International Federation of Red Crescent Societies(IFRC).
 - a. further encouraging the humanitarian aid of other countries,
 - i. the other countries are highly encouraged to provide humanitarian aid through the international organization such as but not limited to the organizations previously mentioned in the paragraph,
- 8. Further recognizes the need of reinforcement on border security and border control of the unified Republic of Korea regarding its Demarcation Line, the Northern border by the Yalu River and the Tumen River, and its borders facing the East and West coast in ways such as but not limited to:
 - a. urging UN security council to operate United Nations Peacekeeping
 Operations(UNPKO) for the purpose of guaranteeing national security in the
 Northern part of the Demarcation Line and the Southern part of the Northern
 border by the Yalu River and Tumen River;
 - b. emphasizing once again that any other measures for border control and the sustainment of the Internally Displaced Persons(IDPs) in the North Korean region is subject to further discussion that will be opened in the near future,
 - c. strongly urging the foreign military force which is currently existing on the peninsula to be stationed below the 38th parallel
- 9. Calls for further discussion on this matter to be made through 5 Party Talks, which consists of the unified Republic of Korea, the People's Republic of China, Japan, Russian Federation, and the United States of America for the purpose of dealing with possible future issues and strengthening diplomatic relationships.
