Trilateral Cooperation for Peace in the Korean Peninsula

The First Committee,

Affirming the role of the Committee on this issue,

Bearing in mind the importance of trilateral peace and cooperation of all Member States,

Acknowledging the importance of peace in the Korean Peninsula,

1. *Desires* denuclearization to be the first step to peace and to happen by denuclearization and evacuation of the United States of America (U.S.A.) Army in the Republic of Korea (ROK) happening in the time period of 10 years by methods such as but not limited to:
 - a. In the time period of 10 years, the Republic of Korea (ROK) and the Democratic People's Republic of Korea (DPRK) having transparency regarding military records with each other and the auspices of the United Nations (UN) such as but not limited to Transparency International (TI) and the International Atomic Energy Agency (IAEA) monitoring and ensuring that both countries' progresses are in check;
 - b. Due to the high cost of denuclearization, countries that are at stake with DPRK's development and possession of nuclear weapons supporting the denuclearization process financially, and with TI making sure the financial resources sent to the DPRK are used only for denuclearization purposes, with the additional conditions of:
 - i. Japan giving additional support in the fields of education and technology required for the industry to the DPRK when they release the captured people of Japan;

- ii. Denuclearization support by foreign nations given only when all non-peaceful nuclear activities are deactivated;
 - c. The ROK rebuilding their army to accommodate their needs for defense and peace and security with the USA Army absent;
 - d. The DPRK and ROK having more peaceful discussions and dialogues in the duration of 10 years and deciding on their form of government and economic structure when they end the war and reunify, and with both Koreas having a fair say in how the government will be run;
 - e. Imposing heavy financial sanctions on the DPRK if the supporting countries see any and all signs of delay in their commitment to denuclearization the Korean Peninsula during the 10 years of the denuclearization process, and gradually relieving those sanctions when the denuclearization efforts are evident with the approval of the United Nations (UN);
2. *Encourages* continuous conversation and preparation towards peaceful unification after denuclearization, with both the DPRK and ROK preparing for reunification by measures such as but not limited to:
- a. The People's Republic of China and Japan assisting both the ROK and DPRK on the process of smooth reunification;
 - b. A confederation of the two independent republics being created with a central government being created and situated between the two borders and both republics having equal influence over political, diplomatic, societal and economic decisions.
